Mixing instructions

Prior to mixing, shake container thoroughly.

Premix the required quantity of MAXXTHOR™ TURBO Fast Action Insecticide with a small amount of water in a clean bucket.

Fill the spray tank half with water and add the premixed MAXXTHOR™ TURBO Fast Action Insecticide. Fill the spray tank with water to the required volume.

Agitate the contents of the spray tank.
Do not store prepared mixture.
