FUMITHOR™ HYGIENE **USE INSTRUCTIONS**

PLEASE ALWAYS CONSULT THE LABEL AND SAFETY DATA SHEET BEFORE USE.

PRECAUTIONS

- Do not use in premises where animals are present. •
- Remove or cover exposed food, food utensils, food processing areas and pet bowls. •
- Extremely dangerous to fish. Fish tanks and aquariums should be removed or covered prior to use • of this product.
- Air Conditioning/Air Ventilation Systems should be turned off while the product is in use.
- If smoke detectors are installed, turn them off. •
- Do not contaminate streams, rivers, waterways with product or used containers.

SAFETY DIRECTIONS

- Do not inhale smoke. •
- Avoid contact with eyes and skin.
- Irritating to eyes. •
- Wear eye protection and suitable gloves.
- Leave immediately after lighting smoke generators.
- Thoroughly ventilate treated areas before re-occupying.

STEP BY STEP USAGE GUIDE FOR FUMITHOR™ HYGIENE Disinfectant Smoke Generator

STEP 1

- Calculate the number of cans to be used based on cubic meters. • (1 g of FUMITHOR HYGIENE[™] for every 5 m³ – 10 m³ (Volume (m³) = L x B x H (meter) divided by 10 = minimum dosage in grams)
- Wear eye protection and mask.
- Wear suitable gloves.

STEP 2

Ensure that all precautions are followed as below:

- Ensure the area is clean and clear of debris.
- Do not use in premises where animals are present.
- Remove or cover exposed food/fruit, food utensils, food processing areas and pet bowls.

- Extremely dangerous to fish. Fish tanks and aquariums should be removed or covered prior to use of this product.
- Air Conditioners/Air Ventilation Systems are to be turned off while the product is in use.
- If smoke detectors are installed, turn them off.
- Ensure the area is securely sealed off all windows closed and doors sealed.

STEP 3

Prepare the tin/s for use:

- Shake the tin of FUMITHOR HYGIENE[™] VERTICALLY (UP AND DOWN) for approximately 5 – 10 seconds dependent on size (large tins for the longer period of time) – this is done to loosen the powder.
- Keep away from any flammable materials.
- Should you be using more than one tin of FUMITHOR HYGIENE ensure you layout the tins from the furthest point and work towards the exit door when lighting the wick

Step 4

Remove the white plastic lid.



• On the 25 g and 50 g tins peel off the metal lid.



Never open the tins inner seals (plastic in the 25 g and 50 g and metal in the 100 g, 400 g and 1 kg tins)



Step 5

• Carefully remove the plastic wick protector.



- Pull the wick protector in a upward direction until it is totally visible.
- Do not shake or bend the plastic wick protector or wick.
- The wick will appear in the centre of the hole in the tin.



Step 6

- Place the generator on a fireproof base, a protective floor covering or in a metal bucket. DO NOT PLACE ON ANY FLAMMABLE SURFACE e.g. carpets, wooden floors etc.
- Ensure the base is secure and level as the product does build up pressure.

Step 7

- Ignite the wick.
 - We recommend a lighter with a extender. DO NOT USE A BLOW TORCH OR SIMILAR ITEM. DO NOT INSERT ANY OTHER OBJECTS SUCH AS CARDBOARD, STRING ETC. TO IGNITE THE PRODUCT.



- Extra wicks can be requested with your order.
- Replacement of Wick should the tin not ignite:
 - Simply remove the old wick and push the new wick through the round hole until it feels like you are pushing it into sand.

- Then shake the tin HORIZONTALLY (LEFT TO RIGHT) to ensure the wick remains in position and is coated with product. SHAKE HORIZONTICALLY NOT VERTICALLY If shaken vertically the posibility of the wick moving is high and will then not ignite.
- Please note the in the larger dosage containers the fumigation may take approximately 2 to 5 minutes before full fumigation will begin.

Step 8

- DO NOT inhale smoke.
- Leave immediately after lighting smoke generators.
- Leave the building, sealing it closed.
- Mark the area with a sign: "Fumigated Area". Signs are available on request.
- The generator will burn for approximately 1 to 2 minutes.



- Keep the area air tight for at least 6 8 hours.
- Our recommendation is to treat in the evening and only open up the area the following morning.

Step 9

 On returning to the area, open all windows and doors, and thoroughly ventilate treated areas for at least 30 minutes before re-entry.

Step 10

Dispose of used generator safely, wrap empty tin in paper and place in waste bin.
DO NOT re-use can.
