Treatment

- · Inspect premises thoroughly and locate all cockroach harbourages.
- Place the ZENITHOR™ GEL COCKROACH BAIT bait spots as close as possible to cockroach harbourages.
- Place bait spots into cracks and crevices away from where they are likely to be removed by cleaning programmes.
- When placing baits remember that the label refers to the full surface area that the cockroaches are likely to traverse e.g. in a kitchen allow for the full surface area of each bench, cupboard etc.
- Good hygiene is essential in any pest management situation. Encourage the removal of other food materials.
- · Do not use chemical sprays near baits.
- · In areas of poor sanitation use more bait placements.

Dosage rate Apply as a 5 mm (0.1 g) diameter bait spot. Apply 2 bait spots per m² and up to 5 spots for heavy infestations.

Retreatment

In areas of high activity the bait may be consumed and further placements needed. Schedule a second inspection about a month after the initial treatment.
