PEST	SITUATION	RATE	REMARKS
Ants	Outdoor perimeter treatment around structures	1-2.5 g per linière metre	Sprinkle evenly in a 30 to 60 cm band adjacent to the foundations of the building, along driveways, paths, gardens and around trees. For best results apply when ants are most active, usually late afternoon. Follow-up visits should be made to inspect bait placement. Reapply as necessary.
	Broadcast application	1 g per m <sup>2</sup>	Apply by shaking uniformly over lawns, gardens and other non-crop areas.
	Ant mounds	20 g per colony or crevice (approx 2 tablespoons)	Sprinkle around each mound (DO NOT use food utensils). For best results do not apply directly to the mound, nor disturb the ants or mound.
Ants and cockroaches	Indoor use	10 g per crack or crevice (approx 1 tablespoon)	DO NOT use in areas accessible to children. Indoor application is limited to inaccessible areas such as cracks and crevices, wall voids and crawl spaces in commercial and residential areas. Apply by shaking into cracks or crevices (DO NOT use food utensils). Remove any loose or excess granules.

**PREVENTION**

- Destroy empty container by perforation and flattening and never use for any other purpose. Dispose in a responsible manner and according to local legislation.

- DO NOT use empty container for any other purpose.
- Empty containers and granules should not be burnt.

**FIRST AID**

**Inhalation:** Not normally required. However, if inhalation has occurred, and irritation has developed, remove to fresh air and observe until recovered. If irritation becomes painful or persists more than about 30 minutes, seek medical advice.

**Skin Contact:** Gently brush away particles. Irritation is unlikely. However, if irritation does occur, flush with lukewarm, gently flowing water for 5 minutes.

**Eye Contact:** Quickly and gently brush particles from eyes. No effects expected. If irritation does occur, flush contaminated eye(s) with lukewarm, gently flowing water for 5 minutes or until the product is removed. Obtain medical advice if irritation becomes painful or lasts more than a few minutes. Take special care if exposed person is wearing contact lenses.

Use only as directed.

**HYMENOPHTHOR ULTRA Granular Ant and Cockroach Bait** is suitable for controlling ants and cockroaches in indoor and outdoor situations. The granules contain a special blend of foods plus fipronil insecticide. Worker ants carry the granules back to the nest. Expect to see fewer ants within one week. For indoor use insect bait stations may be used.

For outdoor broadcast applications use a hand held rotary spreader or similar device which will give uniform distribution. For smaller areas sprinkle uniformly by hand covered with rubber gloves.

For indoor applications use a suitable dust or granule applicator.

- DO NOT apply to a wet ground surface or to areas that are washed or irrigated, or if rain is likely within 24 hours of application.

- DO NOT use with other insecticides or near where they have been applied.
- DO NOT mix with any other insecticide, fertilizer or product of any type.
