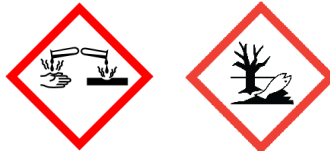

This is a commercial product whose exact ratio of components may vary slightly.

The SWA TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. The STEL (Short Term Exposure Limit) is an exposure value that may be equalled (but should not be exceeded) for no longer than 15 minutes and should not be repeated more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The term "peak" is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.

Section 4 - First Aid Measures

General Information:

In case of human or animal poisoning, call the Griffon Poison Centre 082-446-8946 (24 hr service). Have this SDS with you when you call.

Inhalation: Remove from source of exposure. If signs of toxicity occur contact a Poisons Centre or a doctor. Provide symptomatic supportive care as necessary.

Eye Contact: Gently remove dust from eyes. If irritation does occur, flush contaminated eye(s) with lukewarm, gently flowing water for 5 minutes or until the product is removed. Obtain medical advice if irritation becomes painful or lasts more than a few minutes.

Ingestion: If product is swallowed or gets in mouth, wash mouth with water and spit out. If signs of toxicity occur contact a Poisons Centre or a doctor. Provide symptomatic supportive care as necessary.

Section 5 - Fire Fighting Measures

Fire and Explosion Hazards: There is no risk of an explosion from this product under normal circumstances if it is involved in a fire. Fire decomposition products from this product are unlikely to be toxic if inhaled.

Section 6 - Accidental Release Measures

Accidental release: In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls and gloves. Suitable materials for protective clothing include rubber.

Contain spill. Sweep up and shovel or collect recoverable product into labelled containers for recycling or salvage, and dispose of promptly. Recycle containers wherever possible after careful cleaning. Refer to product label for specific instructions.
