Re-bait dry bait stations as described. Scatter application: The bait should be scattered (do not put in piles) onto dry level surfaces (e.g. pathways, window ledges or in shallow dishes). Avoid very dusty areas. Bait Station application: Set up Stations by sprinkling into shallow tins, lids or similar containers and place where flies congregate. Position Stations out of reach of animals and away from feed troughs, storage or mixing areas. Paint-on application: To prepare a paste for painting, mix 50 g of VECTOTHOR TM Fly Bait with 37.5 mL of water. 15 minutes after mixing the paste can be applied with a brush to spots where flies rest (e.g. walls, joists, window ledges, stable fixtures). Additionally it can be painted onto hessian bags or sheets of cardboard or fabric which are hung in areas frequented by flies. After use the brush can be cleaned with warm water. Spray-on application: To prepare a paste for spraying, mix 10 g of VECTOTHOR TM Fly Bait with 40 mL of water and spray as a coarse spray on to surfaces where flies land at a rate of 1 L per 10m ² . The attractants within VECTOTHOR TM Fly Bait will lure flies to the treated surface where they will attempt to feed; thus picking up a lethal dose. Due to this bait function, only portions of vertical surfaces need to be treated. For areas of 100m ² apply 2 L of spray in bands covering about a third (1/3) of the total surface. Re-baiting: Re-baiting may be necessary in 3-5 days depending on exposure, weather and population density.

Do NOT place baits in locations accessible to domestic animals, livestock or birds.

Do NOT contaminate streams, rivers or waterways with the chemical or used containers.

Do not scatter bait on manure heaps or dispose of treated sacks/cardboard/fabric with manure. Clean up spillage promptly.

Before application remove animals and pets from the areas to be treated. Cover or remove any open food and water containers. Cover or remove (as applicable) fish ponds, aquariums etc. before application.

GENERAL INSTRUCTIONS

VECTOTHOR™ Fly Bait can be applied in many locations. Avoid cool or windy locations because flies prefer warm wind still sites for resting. For best results time applications to begin at the start of the season before fly populations have reached their peak. Fly control should be considered part of an integrated strategy which incorporates good sanitation, appropriate management of breeding sites (e.g. manure and other decaying organic matter) and exclusion measures for preventing access of flies into internal areas.

NOTE: This product is not attractive to all species of flies and control of non-target species may require other means of control.

Restraint: DO NOT place bait in areas accessible to food producing animals or pets.
